Step 4: Add any additional information in Section 4 that relates to awards, accreditations or partners you work with.

Step 5: Utilize the Appendix checklist to support your tracking and progress with the SDGs, this will be helpful during the reporting period. **Note: This tool is optional, and other tracking methods can be used**

Goal 8: Decent Work and Economic Growth

- **Action Ideas:**

- Job creation for local residents, including Indigenous community members.
- Supporting local suppliers and businesses.
- Highlighting local social enterprises, providing information on ethical shopping and sustainable products and/or vendors.

Example:

"We prioritize hiring locally and have created 3 full-time positions within the community. We also source 80% of our food supplies from regional farmers and artisans."

Goal 12: Responsible Consumption and Production

- **Action Ideas:**

- Implementing waste reduction strategies and conducting a post event waste audit.
- Sourcing sustainable materials and minimizing single-use plastics.
- Promoting eco-friendly activities and tours.

Example:

"We've reduced our plastic waste by 50% in the last two years by eliminating single-use plastics and partnering with local refill stations for biodegradable products."

Bonus: If you can share or link to the measured waste reduction over time!

Goal 13: Climate Action

- **Action Ideas:**

- Reducing carbon emissions through energy-efficient infrastructure.
- Promoting low-impact transportation options, such as biking, carpooling, walking
- Supporting carbon offset initiatives.
- Tourists participate in local climate action, such as planting native trees or restoring natural habitats.

Example:

"We've implemented solar energy at our facilities, reducing our carbon footprint by 30%, and encouraged guests to participate in carbon-offset programs for the event."

Your Response:

Goal 14: Life Below Water

- **Actions Ideas:**

- Protecting marine ecosystems by adhering to responsible tourism practices.
- Supporting conservation initiatives for local marine wildlife (e.g. donating a portion of your profits to conservation or research).

Example:

"Through collaboration with local marine conservation groups, we educate visitors on sustainable whale-watching practices and have adopted a code of conduct to minimize disturbances to marine life."

Goal 15: Life on Land

- **Action Ideas:**

- Conserving natural ecosystems surrounding your event/experience space.
- Promoting biodiversity through reforestation or wildlife protection efforts.
- Supporting pollinator species by planting flowers and plants that support their health and wellbeing at the venue.

Example:

"We designed an event layout plan and built infrastructure to minimize soil erosion and other environmental disturbances. Temporary stages, tents, and pathways were set up to prevent trampling of delicate vegetation."

Section 3: Additional SDGs

In this form we identified the main SDGs that tourism experiences, products and services could focus on, but there are a total of 17 SDGs. All of them are important, and we would love to hear if you contribute to more than one! If so, please describe below.

1. **No Poverty:** End poverty in all its forms everywhere.
2. **Zero Hunger:** End hunger, achieve food security and improved nutrition, and promote sustainable agriculture.
3. **Good Health and Well-being:** Ensure healthy lives and promote well-being for all at all ages.
4. **Quality Education:** Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all.
5. **Gender Equality:** Achieve gender equality and empower all women and girls.
6. **Clean Water and Sanitation:** Ensure availability and sustainable management of water and sanitation for all.
7. **Affordable and Clean Energy:** Ensure access to affordable, reliable, sustainable, and modern energy for all.
8. **Decent Work and Economic Growth:** Promote sustained, inclusive, and sustainable economic growth, full and productive employment, and decent work for all.
9. **Industry, Innovation, and Infrastructure:** Build resilient infrastructure, promote inclusive and sustainable industrialization, and foster innovation.
10. **Reduced Inequalities:** Reduce inequality within and among countries.
11. **Sustainable Cities and Communities:** Make cities and human settlements inclusive, safe, resilient, and sustainable.
12. **Responsible Consumption and Production:** Ensure sustainable consumption and production patterns.
13. **Climate Action:** Take urgent action to combat climate change and its impacts.
14. **Life Below Water:** Conserve and sustainably use the oceans, seas, and marine resources for sustainable development.
15. **Life on Land:** Protect, restore, and promote sustainable use of terrestrial ecosystems, manage forests sustainably, combat desertification, and halt and reverse land degradation and biodiversity loss.
16. **Peace, Justice, and Strong Institutions:** Promote peaceful and inclusive societies for sustainable development, provide access to justice for all, and build effective, accountable, and inclusive institutions at all levels.
17. **Partnerships for the Goals:** Strengthen the means of implementation and revitalize the global partnership for sustainable development.
